# 1. Opening of the Meeting

The meeting started at 10.30 hours.

# 3. Approval of previous Minutes

The Minutes 03/21 had been approved and were sent to the Members in October.

# 4.1 Matters arising from the COVID-19 pandemic – decisions of the Board

As stated in the last Minutes, the Board discussed the future exceptions to the rules. The following exceptions concerning the Show Rules are valid until 31.12.2022:

- All Members or their show organising clubs can hold international shows with only domestic judges officiating, no foreign judges needed.
- For all European FIFe Member countries, the number of certificates needed to obtain the titles IC/IP, GIC/GIP resp. SC/SP is set to 5, 7 resp. 10. These certificates can be obtained in 1 country (for IC/IP) resp. 1 or 2 countries (for GIC/GIP and SC/SP). In each class, at least 1 certificate must be obtained at shows organised after 01.07.2020.
- The number of Best in Show Titles in classes 12 and/or 11 to qualify for the title Junior Winner is reduced from 5 to 3.
- Winners Shows may take place in any month in 2022.
- For all Winner Shows, World Show included, organised in 2022, no qualifications are needed for cats to participate.

The exceptions concerning the Judges Rules were discontinued.

# 6. Members' Matters

## 6.1 Correspondence

- a. Members informed the GS of the following changes: details listed on the FIFe website.
  - \* FFM (MX) new Secretary and website
    - \* Aristocat (LI) new president
- b. FB (GB) informed the Board of a problematic situation in the UK regarding a general shortage of vaccinations. Many veterinarians made breeders wait 3 months for the boosters, others did not even take bookings and were struggling with limited supplies. With reference to article 2.3.3 of the BRR, FB asked what to do. They also asked how this would affect show entries. The Board discussed this problem and established this was a national issue that needed to be solved nationally. It was a clear case of "force majeure". In this case, FB should decide how to handle this situation. Regarding show entries, this was a matter between exhibitor and show organiser and could not be handled by anyone else.
- c. SVERAK (SE) wanted to know if the COVID-19 exemptions for show titles would be extended or not. Exhibitors were asking this because the 2022 shows would open for registration soon and there was no possibility to go abroad before that. The board discussed this request by email and answered SVERAK that as they could read in the last board minutes on page 1, item 4.1.b, the extension of all exceptions would be decided at the next board meeting on the 13 of November, which was only 2.5 weeks away. This matter needed careful consideration since it was a whole package of exceptions and the board preferred to discuss and decide that at a meeting where they would all be present and give their contributions.
- d. ANFI (IT) sent a complaint about the correspondence, which Mrs. Carla Rotini had with the Italian ministry of Agriculture. Since Mrs. Rotini was an individual member of 1.DEKZV e.V. the Board decided to forward this complaint to the German FIFe Member.
- e. FFS (SK) sent a question on article 2.6 of the Statutes. One of their members was active as secretary in a Czech WCF club and FFS wondered if this was an infringement of this article. The GS answered them that it was, and they should inform their member to relinquish this position or resign as a member of FFS.#

# 8. Commission Matters.

### 8.1 Statutes, Rules, Standards, EMS List, lists and forms

The Vice-Secretary made draft versions of the 2022 Show and Breeding & Registration Rules, including the appendixes, which were modified by the HWC. He sent these versions to the relevant commissions to check. There were no updates or changes to the 2022 Statutes, General Rules and Breed Council Rules. The new Standards and EMS list would also be updated.

# 8.2 Seminars

Despite the COVID pandemic, there were almost 50 participants present at the GA judges' seminar.

### 8.3 Judges and Standards Commission

- a. The secretary of the JSC sent the updated versions of the 2022 Judges Rules to the GS.
- b. The GS reminded the JSC about the outstanding issue regarding the implementation of the JSC proposal regarding blue eyes and odd eyes in bicolour silver-tabbies BLH/BSH, as accepted by the 2018 GA. The JSC agreed that the modification to the BSH/BLH standard suggested by the Board, met the requirements of their proposal 10 to the 2018 GA. However, they suggested that since this was the only breed/colour variety where 03 was specifically registered by eye colour (62/64), an exception could be made to keep eye colour as part of the EMS code. The board did not agree and decided, in line with the accepted proposal, that all eye-colours should be judged together, and no eye colour codes should be used when registering silver tabby BLH/BSH bicolours.
- c. The GS reminded the JSC about the outstanding recommendation regarding the suggestions from Mrs. Lena Vencliková, International BG B, categories 2, 3 and 4 judge from Czechia, regarding the training requirements of BG A and D student judges (Minutes 3/21, item 8.3.a).

# 8.5 Breeding & Registration Commission

- a. Mrs. Maria Myrland informed the GS that she would be chairman and Mrs. Sarah Johnson, secretary of the BRC.
- b. ICA (ID) sent 6 questions on the breeding and registration of BEN and BLH/BSH:
  - If BEN n \* LO registered cats produce BEN x nt \* kittens, these kittens will be registered in the RIEX register. If these BEN x nt \* kittens are mated with BEN n \* (LO) and BEN n \* kittens are born, will these kittens be registered as LO or as RIEX?
  - 2. If members import a BEN n \*, with blue or cinnamon tabby colours in the ancestry, can we still register this cat in the RIEX registry?
  - 3. Can blue tabby kittens born from BEN n parents be registered as BEN x a \*? And are they allowed to be used in breeding?
  - 4. Can a BSH with EXO in the ancestry be imported in the ICA pedigree book?
  - 5. Only BSH/BLH ny/ay are recognised. If such cats produce cy\*, oy\* or py\* kittens, because many BSH/BLH carry chocolate or cinnamon, can these kittens be registered as BSH/BLH x \*y\* in the RIEX register and allowed to be used in breeding?

6. Only BSH/BLH ny/ay 03 25 are recognised, while ny/ay 03 22/23/24 and ny/ay 01 21 and 02 21 are not. Can cats of these colours be registered as BSH/BLH x ny/ay 03 22/23/24 and BSH/BLH x ny/ay 04/02 21 and are they all awad to be used in breading

22/23/24 and BSH/BLH x ny/ay 01/02 21 and are they all owed to be used in breeding. The Board asked the BRC for their recommendation. The BRC sent their recommendation and explained how to register x-colours in the pedigree book. They stated that BEN and BLH/BSH had no forbidden/illegal colours but there were non-recognized colours/varieties. X-colours in breeds, which are not forbidden in the breed description or standard, can be used in breeding without restrictions. Cats with x-colours must, of course, be registered in the RIEX register. The BRC sent the following answers to ICA's questions:

- 1) Kittens of x-colour parents will be registered in the RIEX-pedigree book.
- 2) You can import cats with x-colours in the pedigree or the cat itself can be an xcolour but they must be registered as x-colours in the RIEX-register.
- 3) That is correct; they should be registered as BEN x a 24 in the RIEX-register.
- 4) Yes, it can; cross breeding is allowed if the breed used for cross breeding is not forbidden in FIFe. The breed used must be a fully recognized FIFe breed.
- 5) Yes
- 6) Yes

The BRC recommended ICA to join the Facebook group for FIFe registrars for questions which dealt with understanding how to register cats and kittens according to our FIFe rules. The Board agreed with the BRC, and ICA was informed of the above.

The BRC sent the clarification of their recommendation concerning silver kittens from non-C. silver parents in a NEM pedigree (see Minutes 03/21 item 8.5.a). This recommendation was not supported by a majority in the BRC. In cases where silver was clear like in this case the FIFe member could change the cat's colour and inform the original FIFe member of the cat of the colour change, in this case Felis Polonia. This NEM female was silver, documented by judge's report and offspring. However, the silver line was broken in this cat's pedigree, so the BRC suggested to add the text "genetic impossible colour in the pedigree" for this cat and her offspring and to register these cats in the RIEX-register. The Board discussed this matter and established that the reason why in the NEM silver and non-silver cats were judged together in the same class, was because it was in many or most cases impossible to see the actual, correct colour in (silver) pointed semi-longhair cats with coat textures like the NEM. The Board considered it undesirable to mention on an official FIFe pedigree that "a colour is genetically impossible." The Board decided that the only possible solution was to use article 5.1.1. of the BRR regarding geno- and phenotype and to indicate on 4 ancestors of the cat in question that the genotype was silver. If this was done, the pedigree could remain in the LO register. NRR should inform FPL of this correction in line with article 4.6.1.

#### 8.6 Health & Welfare Commission

- a. The "old" HWC sent the Minutes of a Zoom meeting in July and their meeting in Riga during the GA week. They also sent updates on Appendices I & II of the BRR regarding Genetic tests and Health examinations in September 2021.#
- b. The HWC sent an answer to SVERAK's question regarding appendix II of the BRR on patellar luxation (PL). Due to the hip dysplasia rule for MCO accepted in 2019 the health examination list was updated but recommendations for PL in cats was forgotten. This would be corrected in the new issue of the BRR. The HWC explained that PL could result from trauma at any age (kittens and adults) but could also have a polygenic inheritance. They stated that a good age to check for PL was when the cat was adult, and its legs fully grown. A check could also be done earlier, e.g., at the veterinary health check when selling the kitten or whenever there were clinical signs that the cat had problems walking, running or jumping. The GS sent this opinion and the new text in Appendix II to SVERAK.
- c. Mrs. Jurgita Gustaitiene informed the GS that the new members of the HWC decided in an online meeting that Mrs. Gustaitiene would be the chairman and Mr. Vladimir Isakov, the secretary. This information was published on the Members Lists.
