

# MINUTES OF THE MEETING OF THE FIFE BOARD 03/22

23<sup>rd</sup> May 2022 – Plzeň, Czechia

#### 1. Opening of the Meeting

The meeting started at 14.15 hours.

#### 2. Approval of the Agenda

The Board approved the agenda for this meeting.

#### 3. Approval of previous Minutes

The Minutes 02/22 had been approved and sent to the Members.

#### 4.1 Matters arising from the COVID-19 pandemic – decisions of the Board

The following exceptions concerning the Show Rules are valid until 31.12.2022:

- All Members or their show organising clubs can hold international shows with only domestic judges officiating, no foreign judges needed.
- For all European FIFe Member countries, the number of certificates needed to obtain the titles IC/IP, GIC/GIP resp. SC/SP is set to 5, 7 resp. 10. These certificates can be obtained in 1 country (for IC/IP) resp. 1 or 2 countries (for GIC/GIP and SC/SP). In each class, at least 1 certificate must be obtained at shows organised after 01.07.2020.
- The number of Best in Show Titles in classes 12 and/or 11 to qualify for the title Junior Winner is reduced from 5 to 3.
- Winners Shows may take place in any month in 2022.
- For all Winner Shows, World Show included, organised in 2022, no qualifications are needed for cats to participate.

#### 4. 2 Matters arising from or omitted in previous Minutes

The Treasurer and GS would update the information about FIFe in Luxemburg.

#### 5. Financial

#### 5.1 Members' and Patronage Members' Payments

The Treasurer showed a list of outstanding payments; 2021 was completely settled only some outstanding payments for 2022 were being dealt with.

- a. The Treasurer travelled to Luxemburg to meet with the two controllers. It was decided that the check in 2023 would take place before or after the board meeting in March or April in Vienna.
- b. The number of shows was currently out of budget; until today the number of shows was 50% less than the normal number

#### 6. Members' Matters

#### 6.1 General

#### Extraordinary situation - Ukraine/Russia do again in line with hand out at GA

The Board discussed the restrictions in place since 01.03.2022, which would end on the 31.05.2022 and discussed how to continue. They also wanted to know if these restrictions should be extended until after the 2023 GA, the 31.05.2023. The Board decided to put these questions to the 2022 GA in line with article 4.8 of the Statutes, as a new item on the agenda. These restrictions were:

- FIFe Members outside Russia may not import any cat bred in Russia in their pedigree books, regardless of, which organization issued its pedigree.
- Exhibitors living in Russia may not enter their cats at any FIFe show outside Russia, regardless of, which organization these exhibitors hold their membership in.

#### 6.2 Correspondence

- a. Members informed the GS of the following changes: details listed on the FIFe website.
  - \* ZFDS (SI) new president
  - \* FFG (GR) changed their name to FGR (see below) new Board and address
  - \* NRR (NO) new board and new president
- b. ICA (ID) asked permission to register a cat from Russia, which had arrived before 01.03.2022, which could be proved with documentation. The Board discussed this request and agreed.#
- c. The secretary of the Greek Member FFG, informed the FIFe Board that they had elected a new board and they decided to rename the organisation to Felis Greece (FGR). The GS sent a confirmation and congratulations and changed the details on the Members lists.
- d. FBE (BE) asked if their member and student judge, Mr. Danijel Iveta could be allowed to lecture at a WCF event to be held in Zagreb on the 25.05.2022. The Board asked the Croatian Member, SFDH, who saw no benefit for FIFe or SFDH and they did not grant permission. The Board agreed with SFDH and FBE was informed.
- e. Bubaste (LT) asked for a confirmation that they could register kittens bred by their individual members living in Russia. They attached a print-screen of item 6.2.i of Minutes 02/22, where the same subject matter was minuted regarding CFCA. The GS answered them in line with the answer sent to CFCA and emphasized that the restriction concerned the IMPORT not the registration of cats. Restricting the registration of kittens would be in conflict with article 4.5 and 5.1.1 of the BRR and would mean promoting the breeding of cats without pedigrees.
- f. FH (HU) asked for guidance regarding the issue of pedigrees for kitten in 2022, sired by a non-white blue-eyed MCO. These kittens were born in the first week of February, so the mating took place in 2021 when breeding with non-white blue-eyed MCO was still permitted. FH was unsure how to deal with the status of the sire on the pedigrees and how to register the kittens that did not have blue eyes. Should they be XLH or MCO since at the time of the mating their father was still MCO.

The Board discussed this matter and concluded that the female was mated in 2021, when the rule restricting breeding with blue eyed MCO with low grade white did not yet exist in the rules and was not valid. Moreover, decisions in FIFe were never retroactive, so it was decided that these kittens should be registered as MCO in their appropriate varieties. The blue-eyed kittens and the sire (MCO male) could not be used for breeding (anymore) in FIFe; as of 01.01.2022, article 6.14 of the BRR applied. The kittens that did not have blue eyes would be normally registered as MCO and could be used in breeding as MCO.

#### 7. Show matters:

#### 7.1 General

- a. SK (FI) informed the Board that one of their clubs had a problem with a show date. They wished to hold their show on the 13-14.08.2022 but there was a show registered in Vyborg (RU), which was only 300 kms away from their venue. SK asked FRU (RU) for permission to hold their show, but FRU did not agree, so SK asked the Board for permission. The Board asked the SC, and the SC agreed to allow the show in Finland. The Board discussed this matter by email and did not agree. SK was informed. It was remarked that normally these matters were handled only by Members not by the Board.
- b. FFM (MX) requested an exception to article 6.1.2.f of the Show Rules. They had invited two FIFe judges, instead of three next to one non-FIFe (CFA) judge to officiate at the shows on the 03+04.12.2022 in Mexico City and hoped this would be allowed. The Board discussed this request and decided to grant this exception.
