## REPORTS OF THE COMMISSIONS



### Report of the Breeding & Registration Commission

BRC

The members of the Breeding & Registration Commission (BRC) are Cecilia Wennergren (SE), Maria Myrland (NO) (Secretary) and Sarah Johnson (UK), (Chairman).

Since our last report, we held no physical meetings except at the last AGA, all matters having been dealt with via e-mail and other electronic means. We dealt with requests from the Board for recommendations regarding new colours, problems understanding the BRR in connection with the registration of cats, etc.

The commission has dealt with these cases since last GA:

- FB (UK) and CSCH (CZ) on a request for a way to register Corin cats.
- Mundikat (NL) on the question of using Silver JBT for breeding.
- FFH (CH) regarding the registration of offspring of MCO from a dominant blue eyed parent.
- FFH (CH) requesting an EMS code for LH Bengals.
- 1.DEKZV e.V (DE) on a request to register a Charcoal OSH.
- Question from the BOM BC regarding the use of AMS-non in the breeding programme

We also present registration statistics. Having now gathered this information for 2019, 2020, 2022 and 2023 it makes for interesting information.

I would like to thank the Board for their cooperation and support, and especially Charles Spijker, for helping with translations, formulating proposals, etc.

Finally, I would like to thank my fellow commissions members for their work and support in the commission.

### Report of the Health & Welfare Commission

HWC

Dear Delegates and Members,

As we gather to review the achievements and challenges of the past year, first and foremost let me express my deepest gratitude to Jurgita Gustaitiene and Petra Černá for their dedication and hard work. Despite facing numerous challenges, the commitment to our Commission has been unwavering, and I am immensely grateful. I also want to extend my appreciation to the Board for their support during these times. Last year has been a testament to the resilience and adaptability of our Federation, but despite facing unprecedented obstacles for some of our national Members, together we have emerged stronger as a community. Throughout the year, the HWC remained deeply engaged through a series of email correspondences and online meetings, ensuring ongoing communication and cooperation despite physical distance, with members of HWC located in two different continents and three different time zones. Digital interactions enabled us to sustain our momentum and drive meaningful progress forward, we didn't have any physical meeting.

Immediately after the 2023 GA, we contacted Members and BCs, after being granted permission from the Board to have direct contact. We discussed hot topics of some breeds, with our emphasis leaning towards prioritizing health concerns. We analysed results of the survey sent out to Members in 2022 and focused on specific requests from their side. We developed a project for a future database and test centre for HD, with input from some of the BCs, and contacted world-leading reading centres worldwide. We contacted professors at different Universities regarding the concern of the RAG BC for HCM.

Very soon, we were contacted by some Members expressing their urgency to face a "ban" of some breeds at a national level, with others under attack by political "animal welfare" organizations or green parties. Due to high pressure from animal rights associations, we decided to temporarily halt our ongoing activities on future tests or breeding strategies and redirect our focus and energy within the legal framework of EU proposals. Understanding the importance of staying on top of changes, we shifted gears to prioritize keeping on top of these developments. This allowed us to stay responsive to the shifting landscape within the European Union and ensure that our European Members continued to align with regulatory requirements at a local level.

We want to make it unequivocally clear: we are not idly waiting but taking proactive steps. We are actively engaged in discussions with leading scientists in the field to fortify our position with concrete scientific

evidence. We are in contact and have had meetings with Dr. Leslie Lyons with the aim of countering and debunking the unfounded allegations made by animal rights associations, ensuring that our stance is firmly grounded in scientific rigor.

We established contact with EU Parliament member Mrs. Sirpa Pietikainen, who was Suomen Kissaliitto candidate for HWC, and thanks to her office we will have first-hand information from an insider point of view. Moreover, we participated in the “Call to Care for Animal Welfare” event in Brussels upon invitation from Felis Belgica, and had direct contact with Dr. Andrea Gavinelli, EU Office General Animal Welfare Unit in the Health and Food Safety Directorate General of the European Commission.

Through our strategic engagement and constructive dialogues with key figures, we have fostered meaningful cooperation that is now bearing fruit. The tangible outcome is reflected in the upcoming Seminar agenda, where our priorities and concerns have been incorporated prominently, resulting in a lecture to all delegates from Dr. Kornilia Zafeiropoulou, who will enlighten us all on the main topics of the much-discussed EU proposals. This cooperation underlines the power of dialogue and partnership in driving positive change, and we look forward to furthering our shared objectives through continued engagement and cooperation.

Last but not least, we're grateful to the other Commissions for the chance to hold joint meetings and share insights. These group sessions enhanced our understanding of the organization. From such joint meetings, recently a new working group emerged, gathering some candidates chosen from Members to work alongside the HWC in order to harmonize FIFe position on a national level, when it comes to governmental issues.

We refrained from presenting any new proposals to our rules at this GA. This pause signifies a choice within our scope of activity, allowing us the necessary time for reflection and ensuring that our future proposals are thoroughly founded and robust, and most of all consistent with the future EU Regulations.

It seems our Members have a similar stance, as we haven't received any communication regarding proposals on health and welfare from their side. Nonetheless, we remain ready and eager to collaborate.

Rest assured, our commitment remains resolute, and we are steadfast in our resolve to advocate effectively for the welfare of cats in the upcoming year.

## Report of the Judges & Standards Commission

JSC

The Judges and Standards Commission (JSC) is composed of 6 members: Mrs Donatella Mastrangelo (Chairman), Mr Steven L. Jones (Secretary), Mr. Francesco Cinque, Mrs Satu Hämäläinen, Mrs Yulia Skabovska and Mr Mirek Skotarczyk.

This past year the Commission could work at full speed! As always, we performed our duties exclusively by email and videoconference. The activity online has been particularly intense, especially last Autumn 2023 with compulsory seminars, plus other online meetings with Breed Councils (BC) and other Commissions.

- Since the last GA, we had 3 video meetings in 2023 and 4 in 2024
- The Judges Rules didn't undertake any change. So, we have cooperated with the Vice-Secretary for the implementation of few changes in breed standards, due to the accepted proposals of GA 2023
- After GA 2023, we prepared new Exam Sets and sent them to the General Secretary who could use them till the end of the year, for all categories, and BG Exams.
- All Exam Questionnaires 2024 in English (Final and Preliminary) were made available in October 2023. And Exam sets for 2024 were ready at the beginning of 2024. A Reactivation Exam has also been prepared and later checked with positive result from the candidate
- Soon after the GA 2023, a Judges Seminar has been organized in Italy, in June, and we thank ANFI for the opportunity given to FIFe Students and Judges that could not attend the GA Seminar.
- Another Judges Seminar is planned for next July. And for this we thank FPL that offered to organize it.
- In October 2023 we organized a Compulsory seminar, again online. There were 14 Students and 6 Judges participating. We experienced a new system for this kind of seminar, splitting it in 3 sessions, so that the huge amount of information would be more diluted, and more time could be available for open discussion with Students. This new arrangement has been very positively received by the participants.
- We have been working to find a solution to the recent scientific findings about the Corin mutation which affects several breeds. The cooperation with the Board and BRC resulted in the proposals we present.
- We gave our opinions to the Board on the inactivity of dormant judges and to Mundikat on possible changes to the JBS to include the silver tabby and the smoke varieties.
- We promoted and participated in 3 FIFe Commissions meetings to discuss common issues and have a common approach towards various subject that may be relevant for FIFe and the Cat Fancy. It was

extremely positive to have such meetings and a broader cooperation among commission with the result of some of the proposals being “joint” proposals this year.

- The comments received last year during the GA seminar and those collected during the years, made us start a project, in cooperation with the Breed Councils, trying to eliminate all “unnecessary faults” from the standards and giving the BC the chance to also make standards changes if considered necessary. We organized online meetings with the BC Secretaries, and the work progressed smoothly. This is just the beginning of a long journey, and more updates will for sure come in the future. The BCs have been extremely helpful, and the cooperation was very effective. We all appreciated working in direct contact and hope for more shared projects.
- We gave our contribution to the breed descriptions now published on the new FIFe website.
- The JSC decided to have periodical informal video meetings with Student Judges, about various subjects related to the Judges training activity. This is a way to make Students feel closer to each other and to build a solid FIFe judges’ community, in addition to the great importance of sharing information and experiences without any barrier or prejudice. Our intention is to reinforce the support already provided (by Members and Mentors) and stimulate their interactions for a more positive general experience. The first attempt was successful and positively received, so we will plan more meetings in the months to come.
- We arranged and prepared the Judges seminar that will take place this coming Saturday mostly focused on the Corin mutation that affects a certain number of breeds in FIFe, and the new EU proposed Regulation on Cats & Dogs welfare.

My personal and sincere thanks go to my fellow Commission Members that have been working really hard this year, and in a very professional way. Thanks also to the Board, the General Secretary and the Vice-Secretary for the excellent cooperation, good suggestions and support received. I also want to thank the other Commissions members for the important chance to have a more direct cooperation and open communication. Something we certainly need and that for sure will help us all to grow up stronger.

The members of the Public Relations Commission (PRC) are Anna Wijbrands (NL), (Chairman) *Adéla Justová* (CZ), and Anžela Fomičeva (Secretary).

We had no physical meetings; all matters were dealt by e-mail and other electronic means. We dealt with requests from the Board for recommendations and help regarding the FIFe 75 year jubilee and how to create interaction with our audience about this milestone on social media.

Since our election as PRC members, we also stumbled on some issues regarding where responsibility lies and who is in charge of certain platforms, the access to these platforms and how we can best work together to get the best and most valuable content.

At this moment, the duties within our commission are not being fulfilled up to the best we could fulfil them. Anžela Fomičeva has most experience in advising cat clubs about possibilities of sponsorships, how to use Facebook to the best its ability to reach maximum amount of exposure, sponsors and exhibitors.

The duties, which Adéla Justová can fulfil and has fulfilled tremendously well over the past year was to generate more data about where the different clubs in FIFe stand regarding social media and generate and read surveys accompanied with follow up action plans specified to the needs per country. Her capacities go much further than this as she can create also more content for FIFe but we were not allowed to do so yet. Anna Wijbrands’ capabilities lie most in the field of visual content, video’s, Instagram content and branding.

The Board and the PRC had some good discussions about FIFe being a brand and where we want to stand for in the world. We hope we will go further into this the coming year and build towards a preset framework what and how we are going to use social media more effectively, a content strategy that will fit FIFe.

At the GA 2024 we will report our findings that came out of our survey last year regarding how the different FIFe members use social media and online platforms currently.

Our further findings are as follows:

- FIFe Instagram exists. PRC has no access. The board is in charge of the Instagram and most commonly votes on its content.
- FIFe’s official Facebook page exists, only the board members have access.
- Regarding FIFe’s new website that was launched earlier this year. We offered help but it was not necessary as the website was in its final face when we were having the meeting with the board.



Goals for 2024-2025:

- Launch a website where all FIFe members can find scientific content and content of Universities globally about cat breeds, their health and their behaviour to use for promotion or defence against unfounded opinions.
- Work together more closely with the FIFe board to create a content strategy for FIFe.
- Continue cooperation with the other commissions to benefit FIFe's position and members globally.
- There needs to be a financial PR budget of some sort to attain the best result for FIFe.
- We don't need German and French as official FIFe languages. English will be sufficient.
- Get clearly defined by the board and GA, what role and duties they want to give the PRC.
- Rethink how FIFe money is spent and how it will benefit the future most effectively

During the period from May 2023 until March 2024, the Show Commission has the following members: Mr. João Noronha (PT) – chairman, Mrs. Thea Friškovec-Keller (CH) – secretary, Mrs. Gøran Vinje (NO), Mrs. Riikka Turpeinen (FI) and Mr. Marcel Frank (NL).

During the past months the work in the Show Commission was performed timely, with pleasure and enthusiasm, based on an excellent teamwork and contact with the Board.

During this period, the Show Commission had two web-meetings: in September 2023 and March 2024. Dear Members,

2023 was a calm year for the Breed Councils (BC). The difficulty remains in getting the renewals done, but 95% was done before mid of February.

In December 2023 we had 31 BCs, consisting of 28 members and 310 individual members. At the time of writing, we have 31 BCs consisting of 31 members and 298 individual members.

Also, the BSH BC was busy with gathering information and knowledge about "copper". There was a joint

meeting of the JSC/BRC and HWC with the BC secretary BSH/BLH to discuss and share opinions about this Corin gene.

In 2023, there was an online meeting with most of the BC secretaries or delegates and the JSC. The BC participants received this meeting was very positively. It was about the Standards and talking how to remove matters, which are logical and the opposite of what already is mentioned in the Standard. This work was done in cooperation with the BCs and the JSC. The goal was to finish this task for the majority of breeds and send these proposals to the GA.

Some BCs show a growth, PER/EXO, DRX gain slowly new members! I would like to point out that we do not have BCs for Ocicat, LaPerm, Turkish Angora, Sokoke and Japanese Bobtail. Perhaps we can encourage members to start one!

We also could encourage members who have the following breeds to join the BCs especially some extra attention for PER/EXO, DSP, MAU, SIN, CHA, SRL/SRS, SPH, MAN/CYM, BUR. We are looking for a BC secretary for the BC TUV after resignation.

Let us motivate our breeders to work together for their breed. As in the current atmosphere where breeds are under scrutiny by animal welfare activists and governments, we need members to show that we breed for health and have this as our priority.

I would like to urge all Members to encourage their breeders to join the BCs so that they have an opportunity to share their knowledge and expertise and have their voice heard where it matters most.

Last but not least, I would like to ask the FIFe Members to be of great assistance when the BC memberships of their members needs to be renewed. This way you will really make a difference. Please respond to the email, send out those invoices to your members and let them know and respond to you as soon as possible. I would kindly like to remember our Members that the BCs renewals must be finished by 31st of January of each year. Let us try this for 2025!

**Motivation:**

FIFe Members are the most important representatives of our Federation and have great responsibilities toward the values and principles promoted by the Federation. In that context, it is unexplainable that Patronage members have to fulfil certain requirements (see General Rules article 2.3) in order to obtain full membership, but as soon as they obtain this status, almost no obligations are left to meet anymore. We believe the time has come FIFe Members should be held accountable for the way they promote our Federation within their own country. A continuing full membership of FIFe, entailing all rights as laid down in our rules, should not be taken for granted, but earned.

**Mundikat proposes that FIFe appoints an Ombudsman.**

The FIFe Ombudsman will deal with complaints about members of FIFe.

The FIFe Ombudsman conducts inquiries into cases of maladministration by members of FIFe or on the basis of complaints from members of a FIFe member.

All FIFe members, clubs and Federations fall under the jurisdiction of the FIFe Ombudsman. All parties must cooperate with the investigation. The FIFe Ombudsman is a second line provision. This means that the complaint or problems must have gone through all available procedures. Only when the proper procedures do not result in a solution the FIFe Ombudsman can deal with the complaint. If the FIFe Ombudsman does not obtain the assistance requested, the Executive Board is to be informed, which takes appropriate action.

The Ombudsman is elected by the GA for the duration of 6 (six) years. He can only be re-appointed once, for a second term of 6 (six) years. The Ombudsman receives an annual remuneration, set by the FIFe GA.

The FIFe Ombudsman must:

- Be completely independent and impartial in the exercise of their duties.
- Refrain from any act incompatible with his duties.
- Not fulfil any function within a FIFe Federation or FIFe Club or any arbitration function in another organization that is Cat Fancy related.
- Not engage in any other function deemed undesirable to perform his duties as an impartial party.

The General Assembly may discharge the FIFe Ombudsman if:

- He no longer fulfils the conditions required to do his duties or is guilty of serious misconduct.
- When he has reached the age of 70 years or at own request.
- When he becomes incapable, e.g. because of bad health, to perform his duties
- When he accepts a function that is in conflict or incompatible with his or her duties
- When he no longer resides in a country where a FIFe member is residing
- When the GA concludes that his actions or the lack thereof are detrimental to the trust bestowed the FIFe Ombudsman.

The FIFe Board may suspend the FIFe Ombudsman for a period of 3 months when there are strong convictions, facts or circumstances that could lead to discharge by the GA. The suspension automatically stops after three months and may be prolonged for a period of three months at a time. The GA can decide not to grant the FIFe Ombudsman a remuneration for the period he was suspended.

The FIFe Ombudsman has no authority to investigate when there is a possibility for an appeal regarding the matter or when the matter can be handed to the Disciplinary Commission of FIFe.

**If this proposal is accepted, a chapter for the Ombudsman needs to be inserted in the General Rules:**

Complaints can only be dealt with by the FIFe Ombudsman when it complies with the following conditions:

- The request and the documentation is dated and signed and submitted in the English language.
- The complaint is regarding an organization within FIFe.
- A complaint has been made with the concerning organization first, but without any proven result. Unless it is not reasonable to expect this in the matter at hand.
- The handling of this complaint took place no longer than one year ago and there is no possibility for an objection or an appeal.
- The complaint does not consider the content of any rule or regulation (but it may consider the application of such a rule or regulation) or the ruling of any Disciplinary Body.
- Comprises a detailed description of the behaviour, the person(s) who conducted this behaviour and the name of the injured party if not the requestor
- The causes for the request are clearly stated and is accompanied with documentation regarding the procedure of the complaint, the results of the investigation by the organisation and the decision of the organisation and the consequences based on this conclusion.


Should the requirements of this article not be met, the FIFe Ombudsman may grant the requester time to enable him to meet all requirements. The FIFe Ombudsman sets this period.

The FIFe Ombudsman is not obliged to start an investigation when:

- The request does not meet the requirements specified.
- The request is unfounded or has no significant interest or the behaviour of the organisation is not very significant
- The request concerns a matter for which an appeal or objection could be made or for which another authority delivered a ruling
- The request concerns an action or behaviour that is or was dealt with by the FIFe Ombudsman, unless there are new facts that could result in a different decision.

Organizations do not need to pay a case fee for the first complaint against them that is dealt with by the FIFe Ombudsman in each financial year. From the second complaint onwards, organizations must pay a fee when the Ombudsman handles a complaint against them. If a case needs to be investigated it becomes a chargeable case, regardless of outcome. This fee is set by the GA and included in Annex 1 of the General Rules.

The Neva Masquerade was recognised in FIFe in 2011 and in the subsequent years has become increasingly popular. NRR believes it is now appropriate to implement a final colour group division for the breed.

### Introduction

This proposal comes as a result of developments in identification of CORIN colour modifiers in a number of recognised breeds within FIFe and proposes a modification to the FIFe EMS system to register these modifiers. This proposal comes after a number of requests from FIFe members who have had problems in registering cats from other cat organisations where these colour modifiers are already recognised.

There is no doubt that FIFe is rather late in modifying/extending the FIFe EMS System to allocate codes for these colours modifiers. Other organisations have had EMS codes in place for a number of years. However, one advantage of this is that FIFe is able to take advantage of a wider range of knowledge and hopefully allocate EMS codes that will remain viable in the future.

### What is CORIN?

It is not easy to explain in layman's language what CORIN is and how it is involved in the coat colour of cats. In agouti (banded) cat hair there are two types of colour granules, phaeomelanin (red) and eumelanin (black). In the hair, MSH (melanocytes stimulating hormone) causes eumelanin production causing the hair to be black. In the agouti (banded) hair, ASIP (agouti stimulating protein) causes the melanocytes to switch to producing phaeomelanin. CORIN (a protein-coding gene) breaks down ASIP allowing MSH to start producing eumelanin black pigment again. This cycle results in the bands on the hair.

Mutated CORIN takes longer to break down ASIP, which causes phaeomelanin red pigment to be produced for longer and misshapen black pigment during the switchover. This has the general effect of making the coat colour look warmer and brighter.

### Proposal

This proposal considers CORIN mutations seen in SIB/NEM, BLH/BSH and KBL/KBS and is in two parts:

1. Technicalities regarding the acceptance of EMS code and recognition.
2. The implementation of CORIN:
  - a. Allocation of EMS Code "u"
  - b. Updating of the Standards of the affected breeds – table of recognised colour varieties
  - c. Updating of the Standards, General Part – colour descriptions.

#### 1. Technicalities regarding the acceptance of EMS code and recognition

The FIFe JSC does not see this as a new colour variety recognition but rather a colour re-registration as a result of advances in genetic testing for colour. Many cats with these CORIN modifiers have been competing very successfully in FIFe shows as golden and have already achieved the highest FIFe titles including numerous BIS, JW, SW etc.

Therefore, the FIFe JSC does not see a full recognition process as appropriate for CORIN modifiers and requests an exemption from FIFe Breeding and Registration Rules Article 11 – Recognition of new varieties.

#### 2. The implementation of CORIN

##### 2a. Allocation of EMS Code "u"

The FIFe JSC proposes to use the EMS Code 'u' for the modifier and it shall be given the generic name "Corin modifier". This modifier will only be available for use with agouti cats and it will not be available for use with red cats as it only affects eumelanin (black pigment) production into the cat hair.

### Remarks

1. Corin modifier is meant as a generic EMS code for colours that have already been given colour names by breeders within FIFe and in other organisations (copper, akita, sunshine etc). These names will be included in the individual breed standards.
2. The EMS system has always been a system based on phenotype. However, there is certain genetic information that can be important for breeding. It is therefore proposed that the FIFe Breeding and Registration Commission develop an additional coding system whereby the various Corin mutations can be added to the pedigree (not as part of the EMS Code itself).
3. The only method described in the FIFe Rules for changing the EMS Code of a cat is to enter it into Class 13C. Other methods of changing the colour by genetic testing proof need to be evaluated.

Some of these faults are also the exact opposite of what is written in the standard (i.e. standard: short nose; fault: long nose) and give no additional or useful information to both judge and breeder. To avoid misunderstanding and different interpretation of these faults from both judges and breeders, the JSC decided to work in cooperation with the Breed Councils. The cooperation has been excellent, we worked side by side for a few months to be able to present standard changes' proposals for a first group of breeds. We hope the GA will support these proposals, which are the result of hard work between the JSC and the Breed Councils.

We feel that, once registered, a cattery name is the property of the individual member of a FIFe member, who should be entitled to request a change once, when he or she considers this necessary for personal, professional, or other reasons. Obviously, a change of name would be considered a new cattery registration, so the cattery registration fee would apply once again.

Article 3.6 in the FIFe Breeding & Registration Rules states that cats without whiskers are not allowed for breeding. In the FIFe Show Rules this criterion is missing in the table - Disqualifying and General Faults. We request that the responsible Commissions (BRC and SC) adapt the article, respectively the table in the respective regulations and submit it for approval to the FIFe GA 2025.

#### Motivation

The two regulations, the FIFe Breeding & Registration Rules and the FIFe Show Rules are contradictory regarding missing whiskers. On the one hand it is not allowed to breed with such animals and on the other hand cats without whiskers may be awarded at shows up to the highest level. This contradiction is totally incomprehensible to outsiders, such as animal welfare organisations or state veterinary authorities and must be eliminated by listing the absence of whiskers in the table of Disqualifying and General Faults or by deleting it from the FIFe Breeding & Registration Rules.

Silver is permitted in most other cat organizations (e.g. CFA and TICA) and this makes it even more complicated for the breeders.

A Judge or Student Judge may only exhibit their own cats “Out of Competition” at the show where they are officiating.

On a 1-certificate FIFe show, divided in categories **for during** 2 or more days, it is not allowed to officiate as a Judge on the one day and exhibit on the other day.


***On a 1-certificate FIFe show, divided in categories for 2 or more days, it is allowed to officiate as a Student Judge on the one day and exhibit on the other day.***

Members of an officiating Student Judge’s household may exhibit their own cat(s) at the show, but not in a category or categories in which the Student Judge is officiating at the show.

### Motivation

It is important to support the education of student judges, but also to enable them to function as exhibitors. In our opinion, it very much benefits their studies if the student judges can be active at shows also as exhibitors. The JSC would like to give Students the chance to apply for the final exam even if one of the rare breeds has not been examined. Breeds can be “rare” depending on different factors, and therefore the list of these breeds may be updated based on the numbers published by the BRC on the FIFe website. At present, the JSC consider as rare breeds the following: JBS, LPL/LPS, MAN/CYM and SOK. For this list of breeds, online lectures will be arranged.

As FIFe, we state to conduct an open doors policy, but at this point, the open doors policy only contains limitations... During the 2022 and 2023 GA, we all expressed that change is needed. We must acknowledge we live in a world where there is not only FIFe and some members of other organisations just want to show their cats in FIFe, but not become full member. That is their right.

The limitation of not showing in higher classes makes no sense... Why don't we allow as many cats as possible at our shows? Let non-FIFe members experience that FIFe shows are the best, that FIFe judges are the best and that they should probably step over to FIFe... But if they do not want to step over, they are still welcome and their cats are still loved. Let the best cat win and go home with the certificate...

Let us conduct a real open doors policy!

### Motivation

Nowadays we have many exceptions for the rules concerning obtaining International titles due to multiple reasons. We all have heard that FIFe is losing members and shows are getting smaller. Individual members are not going to shows, but we have refused multiple proposals aiming to attract and bring back breeders and exhibitors to shows. Our proposal tries to make it as equal as possible to breeders to achieve our already existing titles since for some countries the breeders nowadays has just to drive 100Km and they can attend to shows in other countries (valid for international titles) but in other countries a breeder will not find it possible even if they moved 1.000Km or even worst they would have to deal with political or health barriers on the borders. This rule will support our exhibitors and breeders in current economically challenging times, but it would also send a message of a more sustainable and most importantly, a cat friendly hobby. We believe this rule can be suitable to all our members and no exceptions would be needed anymore.

The competitions, both at local and international level, is today a big outward face and this is where the common person comes in contact with us as a federation. There is today nothing in FIFe's regulations that guides exhibitors when it comes to what amenities a cat is expected to have access to and we feel this needs clarification.

#### Motivation

We see an increased number of cats at our show in classes 7 and 8. We also see that travel and hotel costs have increased for our members, so we see an opportunity to achieve the titles in the home country as a better option than that they stop showing their cat because it is too expensive to travel far.

#### Motivation

During the time with exception of the rules in classes 7/8 we saw that more cats were shown to obtain the titles IC/IP since they did not need to go abroad. In this way their interest in the cat fancy increases and they may want to continue in higher classes. Everything is getting more expensive, and many cannot afford to go abroad. With the continued economic situation and concern about infections we see exhibitors stop showing their cats when they need to travel abroad. Sweden is a long country and those living up north having both long distances and a climate that makes long distance travelling to neighbour countries hard. The world situation is another reason for worry and we also want to protect the environment. We hope that an exemption from the requirement of certificates from more than one country in classes 7/8 will lead them to stay in our hobby and that the conditions look better after 2026.

**1. General**

1.1 Cat Shows

Cat shows are one of the most important promotion events and the presentation of the cat fancy. Besides web sites and social media, cat shows are the most important tools of cat fancy to educate the public about cats of domestic origin, pedigreed or not, and to promote the welfare and a good life for all cats. Information about the cat fancy brought to the community through newspapers, radio, television and social media will normally take place in connection with local cat shows. A cat show is the arena where many potential cat fanciers become active after having been a visitor. Cat shows are also the place where the exhibitors from different international Members meet, where they compete with their cats and where they have the possibility to exchange experiences with each other.

1.2 Code of Ethics for Exhibitors

1.2.1 Principles being the Exhibitor at FIFe Shows

Exhibitors are, besides the cats themselves and the FIFe Judges, one of most important promoters of the cat fancy and have great responsibilities toward the values and principles promoted by the Federation.

Exhibitors, whether only exhibitors or also breeders, are usually the first contact and their behaviour and attitude are among the first impressions people outside the cat fancy experience.

They are expected to:

- show knowledge about cats and breeds, about the welfare of cats, about how to take proper care of them and their needs, and the understanding of a cat’s behaviour
- show knowledge about FIFe and understanding of the basic values and principles identifying the organisation,
- be able to communicate with other exhibitors and other people (e.g. visitors, judges, show organizers) always in a respectful manner, showing tolerance towards each other, despite possible differences, different opinions and different cultural and educational backgrounds; always maintain self-control, support each other in our common interests and goals, and never engage in transgressive behaviour (e.g. harassing, bullying or threatening etc.),
- demonstrate a welcoming atmosphere in the show hall and on social media to influence the public’s positive opinion and attitude towards cats, encourage others to become interested in cat fancy and to join us in common goals for the welfare of cats.

1.2.2 Code of Ethics and responsibility of a FIFe Member

Exhibitors and Breeders are representatives of FIFe and the FIFe Member they belong to and shall conduct themselves as such.

They shall always display a considerate and caring attitude and courteous behaviour whether verbal, written and/or as demonstrated by physical actions.

Whether exhibiting or visiting a show, they shall not cause disruption during or after the show. Social media is considered an extension of the physical public space and respectful behaviour is expected there as well.

Exhibitors and Breeders are the responsibility of the Member to which they belong.

The Member is responsible to act against such Exhibitors and Breeders who do not respect this code of ethics, whether such behaviour is officially lodged in a complaint. or only reported or noticed. This applies to any inappropriate behaviour in connection with cat shows, as well as on social media.

FIFe currently has 41 members in 39 countries and each of them uses its own software for managing its exhibition data.

Since all these computer programs are different and not interconnected it would make sense to set up a joint system for all member countries in order to standardize the software internationally and enhance communication between member countries.


The software creation could be financed by a one-off payment to FIFe from about EUR 500 to EUR 1000 per member. This amount (from about EUR 21000 to EUR 42000) would enable FIFe to have the necessary program set up professionally.

A single system would facilitate not only the registration of titles obtained with certificates from abroad but also the approval of registrations to exhibitions abroad.

All documents would be standardised worldwide and a server with a database of all FIFe-registered cats would be available to all members.

Each member would pay a lump sum and could possibly divide the cost over its individual clubs.

Some countries already have good programs. One of these could be upgraded to become the global program used and financed by all requesting members
